UNCONTESTED (Class 2 Modification to Hazardous Waste Permits)

Item 1. Consideration of an application by NSSI/RECOVERY SERVICES, INC. for a Class 2 Modification to Permit No. HW50269 in accordance with 30 TAC Section 305.69. The permit authorizes operation of a commercial hazardous waste facility that stores and processes small amounts of hazardous waste to be disposed of in bulk off-site. The permit modification authorizes a less than 25% expansion of tank and container storage capacity and updates the permit and incorporated plans. The facility is at 5711 Etheridge in the City of Houston, Harris County, Texas.

UNCONTESTED (Class 3 Modification to Hazardous Waste Permits)

Item 2. Consideration of an application by AIR PRODUCTS MANUFACTURING CORPORATION for a Class 3 Modification to Permit No. HW50134 in accordance with 30 TAC Section 305.69. The permit modification authorizes operation of a container storage area and a by-product storage tank for storage of hazardous wastes that are generated onsite. The facility is at 1423 Highway 225 in Pasadena, Harris County, Texas.

Item 3. APPLICATION BY REXENE CORPORATION for a Class I Underground Injection Control Permit (Proposed Permit No. WDW-303) to authorize disposal of hazardous and non-hazardous wastes generated during the manufacture of

chemicals at its Odessa facility. The permit will authorize injection of on-site generated hazardous and non-hazardous wastes from the production of olefins, polyolefins, styrene and 1,3 butadiene; water treatment process wastes; cooling tower blowdown; storm water runoff; wash water collected in sumps; recovered groundwater; tank car wash water; brine from hydrocarbon storage wells; and wastes generated during well and associated facility closures. The authorized injection rate is not to exceed 1000 gpm, with an average rate of 800 gpm. The total yearly injection volume is not to exceed 420,480,000 gallons. The operating surface injection pressure is not to exceed 1900 psig. disposal well WDW-303 is to be on company property, approximately 1600 feet from the south line and approximately 400 feet from the west line of Section 38, Block 42, T-2-S, of the T&P RR Co. Survey, two (2) miles southeast of Odessa in Ector County, Texas.

UNCONTESTED (Hazardous Waste Permits and Compliance Plans)

Item 4. APPLICATION BY MARATHON LETOURNEAU COMPANY for a hazardous waste facility post closure care permit (Proposed Permit No. HW50263) and compliance plan (Proposed Compliance Plan No. CP50263) at its Longview The proposed permit would authorize post facility. closure care for a three of the cells of a closed landfill. The three cells have a total surface area of 1.25 acres and a total capacity of 15,600 cubic yards. The compliance plan would authorize a corrective action program to remediate hazardous constituents released from the solid waste management units to groundwater and to ensure the Groundwater Protection Standard is achieved. The compliance plan specifies installation and operation of groundwater corrective action systems to remediate the contamination. The wastes formerly managed in the landfill were Class I hazardous and non-hazardous industrial solid wastes generated on-site from the manufacture of heavy equipment. The Marathon Longview facility is on 2,134-acres of land approximately 0.25 mile northwest of the Estes Parkway and Farm Road 1845 intersection and approximately 0.75 mile north of Interstate Highway 20 in the southwestern portion of the City of Longview, Gregg County, Texas.

Item 5. APPLICATION BY ROLLINS ENVIRONMENTAL SERVICES (TX), INC. for an amendment to Permit No. 50089-001 which authorizes

operation of a commercial hazardous waste treatment, storage and disposal facility. The proposed amendment would 1) authorize a new cap design for the North and South Landfills, 2) authorize construction and operation of two container storage areas atop of the closed South Landfill, and 3) revise the facility's closure plan to incorporate closure of the container storage areas. Rollins has also applied to the TWC for two Class 1 permit modifications which 1) authorize installation and operation of three oxygen lances within each incinerator afterburner, and 2) authorize Bin Storage Area (BSA) 1 to manage certain on-site generated wastes and BSA-2 to manage certain bulk solids. Provisions for the two Class 1 Modifications are being proposed at the same time as the proposed provisions for the major amendment. industrial solid waste management facility is on an 86tract of land at 2027 Battleground approximately one (1) mile south-southwest of the San Jacinto Monument in Deer Park, Harris County, Texas.

APPLICATION BY SAFETY-KLEEN CORPORATION for a permit Item 6. (Proposed Permit No. HW50260-001) to authorize the continued operation of an existing hazardous waste storage and processing facility. The facility has been operating since May 1, 1979, and has interim status under the Resource and Conservation Recovery Act (RCRA). proposed permit would authorize three (3) tanks with a combined capacity of 12,324 gallons and one container storage area with a capacity of 4,464 gallons. wastes managed at this facility are Class I hazardous wastes from off-site sources such as auto repair shops and laundry dry cleaners. The wastes are classified as ignitable, toxic and toxicity characteristic (TC) toxic liquids and solids. The waste management facility is at 3333 Federal Road on the east side, approximately 1,600 feet south of Spencer Highway in Harris County, Texas.

1tem 7. APPLICATION BY SAFETY-KLEEN CORPORATION for a Class I hazardous waste permit (Proposed Permit No. HW50341) to operate storage units at its new proposed EL Paso, Texas facility. The authorized storage units will consist of 1) two storage tanks with a total combined capacity of 40,000 gallons, 2) two 162-gallon drum washers, and 3) one container accumulation storage area totaling 6912 gallons. The facility will collect and store off-site generated Class I industrial hazardous waste which is destined for recycling-reprocessing at a Safety-Kleen facility at a different location. Waste materials are to be comprised of spent industrial solvents, degreasers and antifreeze. The facility (to be known as the El Paso II

Facility) will be located within the city limits of El Paso at 6000 Pompano Street in El Paso County, Texas.

The plant site is on Hooper Road, approximately one quarter mile south of Beltway 8 (Sam Houston Parkway) and about three miles west of Texas Highway 288 in the City of Houston, Harris County, Texas.

Outfall 002 discharges only intermittent flows of untreated stormwater. The applicant operates a naval weapons industrial reserve plant which manufactures solid rocket motor propellant. The plant site is southwest of the City of McGregor just west of State Highway 317, bounded on the south by Farm to Market Road 2671 and on the north by the St. Louis Southwestern Railway in Coryell and McLennan Counties, Texas.
