Re: Application of Bahamas Laguna Azure, LLC; TCEQ Docket No. 2023-1560-MWD

The above-referenced matter is scheduled to be considered by the Texas Commission on Environmental Quality (Commission) at its August 28, 2024, public meeting. On August 15, 2024, a motion for continuance of this matter was filed on behalf of Bahamas Laguna Azure, LLC (Bahamas). The motion explains that Bahamas and one of the hearing requesters, the City of Royse City, have reached a settlement agreement, which provides for withdrawal of the Application after certain milestones have been met. Therefore, Bahamas requests that the Application remain pending to effectuate the terms of the settlement agreement. Counsel for Bahamas certified that he consulted with counsel for the TCEQ Executive Director, counsel for OPIC, and counsel for the only hearing requesters, City of Royse City and North Texas Municipal Water District, and these parties did not express opposition to the motion for continuance.

Pursuant to 30 TAC § 10.4 and the Commission's Resolution issued on February 2, 2009, Docket No. 2009-0059-RES, this matter is hereby continued to a future Commission Agenda meeting and will not be considered at the Commission's August 28, 2024, public meeting. No further replies are authorized by this continuance. The General Counsel will inform the parties by separate letter if the Application will be set for consideration at a future Commission Agenda meeting.
